Notable Representations

- Defended a Madison-based garden tool start up, Woodland Tools, against global competitor Fiskars' claims for design-patent infringement, trade-secret misappropriation, tortious interference, and false advertising—obtained complete summary-judgment dismissal of all Fiskars claims and prevailed at trial on Woodland Tools' Lanham Act false advertising counterclaim, resulting in a jury finding that Fiskars engaged in willful false advertising
